Marcia C. Ferranto named NCRA Executive Director and CEO

Twenty-five year seasoned nonprofit executive and first woman CEO to lead NCRA will bring fresh perspectives and leadership skills

RESTON, Va., Oct. 2, 2017 — The National Court Reporters Association (NCRA), the country's leading organization representing stenographic court reporters, captioners, and legal videographers, announced today that its board of directors has chosen Marcia C. Ferranto as the organization's next Executive Director and CEO.

"After a comprehensive search and interview process, the board is pleased to have found the best individual to assume leadership of our national association," said NCRA President Chris Willette, RDR, CRR, CRC.

"Marcia has a track record of strong leadership both inside and outside of Washington, D.C. This, combined with her deep nonprofit industry knowledge, makes her uniquely qualified to lead NCRA successfully into the future," she added.

The selection of Ferranto caps a search process facilitated by the American Society of Association Executives that offers its members a service of placing association executives in some of the nation's largest and most prestigious nonprofit organizations. A large initial prospect pool was narrowed by stages to a group who interviewed with the board's search committee and then to a final round that met with board leadership.

"Marcia is the best choice from a deep pool of interested and highly qualified candidates," Willette said. "She has been a successful association executive serving in multiple capacities. Most importantly, she is a great fit with each of the four 'critical leadership competencies' we evaluated as part of our selection process: strategic agility, business acumen, vision, and mission-driven orientation. We're delighted that she's accepted the position," Willette added.

"NCRA has truly paved the way for the court reporting industry through its efforts, and I am honored to have been chosen to lead it," Ferranto said. "The opportunity ahead for NCRA is vast, and to seize it, we must come together with laser-focused intention and continue to promote the court reporting industry as one of the most respected professions within the legal system."

Prior to joining NCRA, Ferranto served as President and CEO of the Women's Transportation Seminar International and the Women's Transportation Seminar Foundation in Washington, D.C. During her tenure with WTS, she worked closely nationally and internationally with the U.S. Departments of Transportation and Labor as well as federal, state and local officials. She also doubled the membership size of WTS and added programs that will impact the transportation industry for years to come.
